Drugs of Abuse Panel with and without Confirmation and Comprehensive Drug Analysis

Effective Date: April 11, 2021

The drugs of abuse panel (DAU) has changed for all Beaumont campuses:

- Drugs of abuse with confirmation (LAB6862)
 - Samples will be screened and all positive results will be confirmed by mass spectrometry assays.
 (Exception: confirmation for THC is only performed for patients younger than 21 years old)
- Drugs of abuse without confirmation (LAB8506)
 - Only screen results will be provided; positive screen results will <u>not</u> be automatically confirmed unless requested by a provider.
 - All positive screen results should be considered as presumptive positive.
- Drugs and drug classes included in the DAU: Amphetamine/Methamphetamine, Barbiturates, Benzodiazepines, Cocaine, Methadone, Opiates, PCP, THC, Oxycodone, Fentanyl.

Drugs of Abuse with Confirmation - the following drugs are included in confirmation testing:

Amphetamines:	Amphetamine, Methamphetamine, MDA, MDMA
Barbiturates:	Phenobarbital, Butalbital, Secobarbital, Pentobarbital
Benzodiazepines:	Diazepam, Nordiazepam, Temazepam, Oxazepam, Alprazolam,
	Clonazepam, Lorazepam, Midazolam, Flunitrazepam, Flurazepam,
	Triazolam, Estazolam, Clobazam, Chlordiazepoxide
Cocaine:	Cocaine and metabolites
Methadone:	Methadone and metabolites
Opiates/Oxycodone/Fentanyl:	6-Acetylmorphine, Codeine, Morphine, Hydrocodone, Hydromorphone,
	Oxycodone, Oxymorphone, fentanyl, norfentanyl
PCP:	Phencyclidine, 3-methoxy phencyclidine
THC:	THC

Comprehensive Drug Analysis (LAB6854): the following components are included:

- 1. Drugs of Abuse with Confirmation
- 2. Urine Acetaminophen and Salicylate Screen
- 3. GC-MS (gas chromatography-mass spectrometry): this is an untargeted drug screen approach based on an inhouse drug library including more than 1200 drugs and metabolites. Common illicit, over-the-counter, and prescription drugs may be found by GC-MS.
